PARADE LINE-UP: **Please check-in floats or vehicles by 3:30 pm on Sunday, June 9**th at the parking lot in the Truman Annex (adjacent to the splash pad on Southard Street).

Participants walking or riding in the parade must be in place by 4:30pm. The Parade will kick-off at 5pm and follow the parade route down Duval Street to the 1300 block of Duval.

We suggest you bring water to keep hydrated during the parade. All floats must carry fire extinguisher and adhere to city, police, and fire regulations. No live fires. No refueling on the parade route. No alcohol or drugs.

No nudity or lewd behavior will be allowed.
